CLAIMS AND AVOIDANCE ACTIONS**


The Court, having considered Receiver Michael Grassmueck's Application for Order Extending Deadline for Commencing Third Party Claims and Avoidance Actions under the Distribution Plan in this action, and good cause appearing therefor, hereby GRANTS THE APPLICATION.

The Court orders as follows:

1. The Distribution Plan is modified as follows. The date under Section X.B.1 (p. 39), Section VI.B.4 (p. 25), and Section VIII.B.3 (p. 29) of the Distribution Plan [Docket No. 875] regarding the time to commence, assert or bring Third Party Claims, including lender liability claims against a Secured Party, and Avoidance Actions (as such terms are defined Section IV of the Distribution Plan), is extended to and replaced with the date "July 30, 2010".
