**ORDER GRANTING FIRST APPLICATIONS FOR PROFESSIONAL  
FEES AND EXPENSES**

This Court, having reviewed the First Interim Fee Applications (the "Fee Applications") for the period from June 4, 2007, through April 30, 2008 (the "First Application Period") of (i) Michael A. Grassmueck (the "Receiver"), the duly appointed receiver for Global Online Direct, Inc. and its subsidiaries and affiliates and any entities controlled by them, (ii) Receiver's general counsel, Allen Matkins Leck Gamble Mallory & Natsis, LLP ("Receiver Counsel"), (iii) Receiver's local counsel, Arnall Golden Gregory LLP ("Local Counsel"), and (iv) Receiver's accountant, Financial Forensics ("Receiver Accountant"), and good cause appearing therefore, orders as follows:

1. Each of the Fee Applications filed by Receiver, Receiver Counsel, Local Counsel, and Receiver Accountant, are approved in their entirety.
2. The Receiver's request for fees of \$124,558 and costs of \$6,158.67 for the First Application Period is granted in full. The Receiver is authorized to pay himself these amounts from receivership estate (the "Receivership Estate") funds.
3. Receiver Counsel's request for fees of \$414,982 and costs of \$25,285.93 for the First Application Period is granted in full. The Receiver is authorized to pay Receiver Counsel these amounts from Receivership Estate funds.
4. Local Counsel's request for fees of \$26,754 and costs of \$1,876.14 for the First Application Period is granted in full. The Receiver is authorized to pay Local Counsel these amounts from Receivership Estate funds.
5. Receiver Accountant's request for fees of \$158,632.95 and costs of \$2,501.82 is granted in full. The Receiver is authorized to pay Receiver Accountant these amounts from Receivership Estate funds.
6. Receiver, Receiver's Counsel, Local Counsel, and Receiver Accountant, have the right to seek payment of their fees and costs in subsequent fee applications in this case; and
7. The fees and costs awarded pursuant to this Order represent an interim award and are, therefore, subject to further review by this Court at a final fee application hearing.
