**NOTICE OF FINAL APPLICATIONS FOR PROFESSIONAL FEES
AND EXPENSES**

PLEASE TAKE NOTICE THAT Michael A. Grassmueck (the "Receiver"), the duly appointed receiver for Global Online Direct, Inc. ("Global") and its subsidiaries Global Online Depository, Global Online SPIP, Global Online Auction Stores, Triple Diamond B, Bodaga Bay, Bodaga Bay Trucking, Inc., Catherine Crick Riders, Double B Broadcasting, Inc., The AM Show, Double B MPG, Global Online Direct, U Loan We Pay, and Bargain Hunter, Inc. and their subsidiaries and affiliates and any entities controlled by them (collectively referred to as the "Receivership Entities"), Receiver's general counsel, Allen Matkins Leck Gamble Mallory & Natsis, LLP ("Receiver Counsel"), Receiver's local counsel, Arnall Golden Gregory LLP ("Local Counsel"), Receiver's forensic accountant, Financial Forensics ("Forensic Accountant"), and Receiver's general accountant, Moss Adams LLP ("General Accountant"), have hereby moved this Court (the "Motion") for approval of each of their Final Applications for Professional Fees and Expenses (the "Fee Applications").

By the Fee Applications, the Receiver and each of its professionals (collectively, the "Receiver and Professionals") requests that the Court enter Orders approving fees and expenses incurred by the Receiver and each of its professionals for the period from March 1, 2010, through closing date (the "Final Period"). In this Final Period, the Receiver and Professionals request approval of the following:

A. Receiver

The Receiver requests approval of fees of \$29,731.50 and costs of \$19.33 for the Final Period.

B. Receiver Counsel

The Receiver Counsel requests approval of fees of \$14,789.88 and costs of \$302.88 for the Final Period.

C. Local Counsel

The Local Counsel requests approval of fees of \$100 for the Final Period.

D. Forensic Accountant

The Forensic Accountant requests approval of fees of \$253 for the Final Period.

E. General Accountant

The General Accountant requests approval of fees of \$22,751 for the Final Period.

As set forth in each of the Fee Applications, the Receiver and Professionals have demonstrated that each of their services has benefited the Receivership Estate. The Receiver and Professionals have worked closely together, and ensured to avoid duplicative efforts. As set forth in the Fee Applications, the Exhibits attached thereto reflect the fair and reasonableness of the compensation requests based upon the descriptions of the quality of the work performed, the time records presented, and the necessity of such work and time spent in each of the noted categories.

As previously communicated to the Court, on or about May 20, 2010, the receivership estate has capped all fees and expenses of the Receiver and Professionals for the Final Period to the amount of \$75,000 ("Final Cap"). The total of the Receiver and Professionals' fees and expenses is \$67,947.59, which is under the Final Cap. Any

portion of the Final Cap which is unused will be included in the distributions to only those claimants who hold allowed claims of \$10.00 or more, to ensure that the cost of processing distribution of these funds would not actually exceed the amount of the distribution.

In addition, the SEC has reviewed each of the Fee Applications, and provided comments and requested changes to certain of the Fee Applications. The Receiver and Professionals have responded to the comments and made the requested changes in the applicable Fee Applications. With the comments addressed, and requested changes made, the SEC has advised that it will not file an objection to the Fee Applications. Finally, the Receiver, Receiver Counsel, Local Counsel, and Forensic Accountant in this case request that the Court deem all prior interim awards of fees and costs as final.

PLEASE TAKE FURTHER NOTICE that the Fee Applications are set without hearing, unless otherwise ordered by the Court pursuant to Local Rule 7.1(E), and any opposition shall be filed no later than fourteen (14) days after service of the Fee Applications, pursuant to Local Rule 7.1(B). Failure to file an opposition shall indicate that there is no opposition to the Fee Applications pursuant to Local Rule 7.1(B).
