**ORDER GRANTING APPLICATIONS FOR PROFESSIONAL FEES AND  
EXPENSES FOR THIRD INTERIM PERIOD**

This Court, having reviewed the Fee Applications (the "Fee Applications") for the period from March 1, 2009, through February 28, 2010 (the "Third Interim Period") of (i) Michael A. Grassmueck (the "Receiver"), the duly appointed receiver for Global Online Direct, Inc. and its subsidiaries and affiliates and any entities controlled by them, (ii) Receiver's general counsel, Allen Matkins Leck Gamble Mallory & Natsis, LLP ("Receiver Counsel"), (iii) Receiver's local counsel, Arnall Golden Gregory LLP ("Local Counsel"), (iv) Receiver's special litigation counsel, Larkins Vacura LLP ("Special Counsel"), and (v) Receiver's accountant, Financial Forensics ("Receiver Accountant"), and good cause appearing therefore, orders as follows:

1. Each of the Fee Applications filed by Receiver, Receiver Counsel, Local Counsel, Special Counsel, and Receiver Accountant, are approved in their entirety.

2. The Receiver's request for fees of \$108,291.50 and costs of \$7,416.88 for the Third Interim Period is granted in full. The Receiver is authorized to pay himself these amounts from receivership estate (the "Receivership Estate") funds.

3. Receiver Counsel's request for fees of \$135,681.84 and costs of \$1,740.89 for the Third Interim Period is granted in full. The Receiver is authorized to pay Receiver Counsel these amounts from Receivership Estate funds.

4. Local Counsel's request for fees of \$9,545.00 and costs of \$16.50 for the Third Interim Period is granted in full. The Receiver is authorized to pay Local Counsel these amounts from Receivership Estate funds.

5. Special Counsel's request for fees of \$66,118.00 and costs of \$5,107.62 for the Third Interim Period is granted in full. The Receiver is authorized to pay Special Counsel these amounts from Receivership Estate funds.

6. Receiver Accountant's request for fees of \$9,350.50 and costs of \$218.24 for the Third Interim Period is granted in full. The Receiver is authorized to pay Receiver Accountant these amounts from Receivership Estate funds.

7. Receiver, Receiver's Counsel, Local Counsel, Special Counsel, and Receiver Accountant, have the right to seek payment of their fees and costs in subsequent fee applications in this case; and

8. The fees and costs awarded pursuant to this Order represent an interim award and, therefore, subject to further review by this Court at final fee application hearing.
